Priority Patrols:

The priorities this month were ASB use of vehicles, ASB in Betty Eastwood Park and speeding throughout the parish.

Crimes:

Calder Grove

There were eight reported offences in Calder Grove in December. All eight were classed as serious acquisitive crimes.

The first of these was a theft from motor vehicle at Cedar Court where the suspect has smashed the window of a vehicle and stolen property from inside. Suspects have been arrested and charged for this offence.

The second also occurred at Cedar Court. It was a theft of a Ford Transit that was left locked and secure. All enquiries have been completed and no suspect/s have been identified.

The next three were all burglary businesses at Cedar Court where suspect/s have removed the windows from ground floor rooms, climbed in and stolen property belonging to guests. All lines of enquiry have been completed and the crimes have been filed.

The next was a burglary residential on Denby Dale Road where suspects have broken into the house and stolen keys for a Mini and VW Golf. The suspects have then stolen the vehicles. The Mini was subsequently used in a robbery and has been recovered, but the Golf is still outstanding. The crime is still under investigation.

There was another burglary residential on Denby Dale Road where the suspects have broken into a house, conducted an untidy search and stolen property. The investigation is still ongoing.

The last was a burglary residential on Broadcut Road where the suspect/s have entered an insecure shed, but stolen nothing. The crime has been filed.

Chapelthorpe

There were no reported offences in Chapelthorpe in December.

Crigglestone

There were seventeen reported offences in Crigglestone. Of these three were classed as serious acquisitive crimes.

The first of these was a burglary residential on Common Way where a shed has been broken into and a bicycle taken. The crime is still under investigation.

The second of these was a burglary residential on Painthorpe Lane. This occurred at Singh and Booze where the suspect/s have broken into the residential part of the building, causing damage, and then into the shop where they have attacked the ATM and stolen property. The crime is still under investigation.

The third was a burglary business at Crigglestone Nursery School where the suspect/s have smashed a window in a shed and stolen property from inside. All enquiries have been completed and no suspect/s have been indentified.

The other offences consisted of a domestic related assault on Woodmoor Rise, an assault at a football match at Crigglestone Sports Club, two assaults on High Street, malicious communications on Mackie Road, The Links, Cliff Drive, Garden Terrace, West View, a dangerous dog on Swallow Way, a sexual offence at an address on Daw Green Avenue, and damages on New Hall Close, Daw Green Avenue and Painthorpe Lane.

Durkar

There were ten reported offences in Durkar. Of these four were classed as serious acquisitive crimes.

This was a theft from motor vehicle at Premier Inn where suspect/s have attacked the locks of a van and stolen tools from the back. All enquiries have been completed and the crime has been finalised.

There was a burglary residential on Hollin Drive where an unknown suspect has broken into a shed, but stolen nothing. The crime has been finalised.

There was an attempt burglary residential at an address on Hollin Drive where the suspect/s have tried to force entry to a garage but failed. No suspect/s have been identified and the crime has been filed.

The last of these was a theft from motor vehicle a Hampson's Plant World. The suspects have arrived on a moped and stolen the headlights from a car. A suspect has been arrested for this offence and the investigation is still ongoing.

The other offences consisted of a malicious communication and a public order offence on Denby Dale Road, a theft from shop on Denby Dale Road East, a theft (other) on Durkar Court, and public order offences on Hollin Drive and Willow Garth.

Hall Green

In Hall Green there were ten reported crimes in December. Of these three were classed a serious acquisitive crimes.

The first of these was a burglary business at the Bay Horse on Stoney Lane. Suspect/s have broken in and stolen and laptop and the change from the pool table. All enquiries have been completed and the crime has been filed.

The second was an attempt burglary residential on Copeworth Drive where a shed has been attacked, but no entry has been gained. A bike was stolen from the garden, but recovered from a nearby hedge. All enquiries have been completed and no suspect/s have been identified.

The third was a burglary business at the Hall Green Garage on Stoney Lane. The suspects have gained entry by smashing the front door. Once inside they have selected and removed property. All lines of enquiry have been completed and no suspect/s have been identified



The fourth is an attempted burglary business at Elamis, Painthorpe Lane where the suspect/s have tried to prize open a rear window but failed. All lines of enquiry have been completed and the crime has been filed.

The fifth was a burglary residential on Marshall Avenue where the suspect/s have broken into a shed and stolen bicycles and scooters. All lines of enquiry have been completed and the crime has been finalised.

The other offences consisted of an assault on Lowmoor Crescent, a malicious communication on Hollingthorpe Avenue, a vehicle interference on Jubilee Street, a public order offence on Painthorpe Lane, and a theft (other) on Stoney Lane.

Newmillerdam

There were no reported offences in Newmillerdam.

Crigglestone
