Priority Patrols:

The priorities this month were ASB use of vehicles, ASB in Betty Eastwood Park and speeding throughout the parish.

Crimes:

Calder Grove

There were two reported offences in Calder Grove. Of these one was classed as a serious acquisitive crime.

This was a report of a burglary residential at an address on Sandpiper Road where the victim's garage has been broken into while they have been on holiday. An untidy search was conducted, but it does not appear that the suspect/s have stolen anything. The investigation has been completed and no suspect/s have been identified.

The other reported crime consisted of a dangerous driving on Denby Dale Road.

Chapelthorpe

There were three reported offences in Chapelthorpe. Of these one was classed as a serious acquisitive crime.

This was a burglary residential on Hall Lane where suspects have broken into the garage and stolen an off-road motorbike. Enquiries are still ongoing into this offence.

The other reported crime consisted of a public order offence at the Pennine Camphill Community and a harassment on Boyne Hill.

Crigglestone

There were twenty reported offences in Crigglestone. Of these four were classed as serious acquisitive crimes.

The first was a report of a theft of motor vehicle on Pugneys Avenue. It is believed that the complainant's keys were stolen prior to the vehicle. The vehicle was located by the police in Leeds. The investigation is still ongoing.

The next was a burglary business at the Village Institute where suspect/s have gained entry by smashing a window. The crime has been finalised pending results from CSI.

The next was a report of a burglary residential on Fishponds Drive where the suspects have gained entry by attacking the lock on the rear doors. The victim was in at the time of the offence, but did not see or hear the suspects. The suspects made off with property from inside. The investigation into this offence is still ongoing.

The last was an attempt burglary residential that occurred on Woodmoor Rise where suspect/s unknown have removed a window pane. Victim was asleep downstairs and was disturbed. Suspect/s made off from the scene. All lines of enquiry have been completed and the crime has been filed.

The other reported crime consisted of a breach of restraining order on Common Way, a breach of non-molestation order on Garden Terrace, two common assaults (verbal assaults) on Woodmoor Rise and Painthorpe Lane, a public order offence and an assault on Mackie Road, a domestic related theft on The Links, a possession of drugs and a damage on Swallow Way, a harassment on Painthorpe Lane, a harassment on Haslegrave Park, three assaults at Mackie Hill School, an assault on Woodmoor Drive and a rape at an address on Woodmoor Close.

Durkar

There were two reported crimes in Durkar in January. Of these one was classed as a serious acquisitive crime.

This was an attempted burglary business at the Red Kite pub where the suspect/s have tried to force their way in through the rear doors but failed. All lines of enquiry have been completed and the crime finalised.

The other reported crime was a damage on Denby Dale Road East.

Hall Green

There were ten reported crimes in Hall Green in January. Of these three were classed as serious acquisitive crimes.

The first was a report of a burglary residential at an address on Copeworth Drive. The suspect was the ex-partner of the victim. They were dealt with, but there was insufficient evidence to prove the offence.

The second was a burglary business and community at the Hall Green Community Centre where the suspect has gained entry through an insecure side door and once inside has removed a large amount of property. Some of the property was located by local residents nearby and returned, but the majority remains outstanding. At this stage all available lines of enquiry have been completed and the crime has been filed.

The third was a report of a theft of motor vehicle on Hollingthorpe Grove. The suspect was arrested and charged.

The other reported crimes consisted of a damage at Copeworth Drive, a malicious communication on Hollingthorpe Lane, two possession of drugs and an affray on Copeworth Drive, a damage on Painthorpe Lane and an assault on Hollingthorpe Road.

Newmillerdam

There were four reported crimes in Newmillerdam. Of these two were classed as serious acquisitive crimes.

The first was a report of an attempted burglary business at La Fortezza where suspect/s have attacked an outbuilding, but failed. A suspect was arrested for this offence, but there was insufficient evidence to charge.

The second was a report of a burglary business on Barnsley Road where a large quantity of cable was stolen. All available lines of enquiry have been completed and no suspect/s have been identified.

The other recorded crimes were possession of drugs and possession of a bladed article on School Hill.

Anti-Social Behaviour:

Calder Grove

There were two ASB related calls in January. They were both regarding fly tipping. One was on Sandpiper Road and Broadcut Road.

Chapelthorpe

There were two ASB related calls in January. They were both regarding fly tipping on Wood Lane within two days of each other so may have been about the same rubbish.

Crigglestone

There were five ASB related calls in January. Four of these were about fly tipping on Painthorpe Lane. The other related to a nuisance youth on Woodmoor Drive from Daw Green Avenue. This was referred to the NPT.

Durkar

There was one ASB related call in Durkar. This was about nuisance youths hanging around the callers car on Durkar Lane.

Hall Green

There was one ASB related call in January. This was relating to vehicles parking outside Dane Royd School.

Newmillerdam

There were no ASB related calls in Newmillerdam.

Officer Activity:

PCSO 438 Kuritzin reports:

12/01/2018 between 2300 x 0200

Safe scheme carried out between 2300hrs and 0100hrs on 12/01/18. Areas looked at were the KFC/Starbucks car park off Peel Avenue and the areas of Crigglestone, Chapelthorpe and Hall Green. There were no calls for service.

PC 6487 Steel reports:

17/01/2018

Patrols made of area on 17/01/2018. I have received information that bikes have been inside Betty Eastwood Park so I patrolled that area. The problem initially was that I was unable to get my bike into the park due to gates and fencing. I patrolled the area on foot and could see several motorbike tracks. I have liaised with the local PCSO's who have explained to me where there is an access point that I may be able to get my bike through so I will be able to enter the park.

I also patrolled Crigglestone Rugby fields and the surrounding fields/woods. The woods were exceptionally muddy due to inclement weather and no signs of any bikes at all could be seen. I also patrolled Seckar Woods, again with no issues.

Patrols were made of general Crigglestone area including High Street. 1 X TOR issued and completed to driver for using mobile phone whilst driving.

No other issues in area.

PC 3051 May reports:

30/01/2017 between 0100 x 0400

Proactive patrols conducted in the Crigglestone area. Males stopped on Denby Dale Road. Details checked and no further action taken. Alarm sounding at St James' School. Insecure door found and property searched. No evidence of entry gained and nothing stolen. Handed over to Caretaker. No other issues.
