### **Priority Patrols:**

Durkar Low Lane Hollin Lane Denby Dale Road.

Parking issues outside of the Kingfisher.

HGVs on Hollin Lane and Durkar Lane (on Durkar Lane there is no restriction going up the hill, but there is one going down)

Friday at 2000 at the Hall Green Community Centre Late night proactive patrols.

#### **Crimes:**

### Crigglestone

A domestic related assault occurred on Garden Terrace involving a child and grandparent. The investigation is ongoing.

Another assault occurred on Hopewell Way after an RTC. The suspect punched the victim causing no injury, but the crime has been filed as the victim declined to prosecute.

A burglary occurred on Mackie Hill Close. Entry was gained to the property by attacking a rear window. A TV was stolen, but the suspects were spooked and left the TV nearby. The investigation is onging.

Another burglary occurred on Hollin Lane where entry was gained by attacking the rear door. On this occasion no property was stolen. The investigation is still ongoing.

A public order offence occurred at a commercial property on High Street between a customer and the employee. The victim declined to prosecute and the crime has been filed.

A theft of a folder and cash occurred and the All Blacks. The property was stolen from the changing room. No suspect has been identified and the crime has been filed. Also at the All Blacks a bin was set on fire. The investigation is complete and no suspect has been identified.

There was a report of a burglary dwelling at an address on Dennington Lane. The suspect/s gained entry through an insecure front door, but did not steal anything. This crime has been filed.

Two crimes of assault were recorded at the same address on Fishponds Drive involving a husband and wife. Neither party wanted to prosecute each other and so the crimes were filed after interview.

There was a report of theft on West View. The victim has been working at an address and left their tools there. The tenant at the address found the tools and put the outside and they were stolen from there. All lines of enquiry have been completed and the crime has been filed.

### Working in partnership to reduce crime

There was a crime of pervert the course of justice on Cliff Road. The suspect was caught speeding and tried to provide false details. They were arrested and discovered to be a disqualified driver also.

A serious assault occurred at an address on Durkar Lane where the victim received a deep cut to the cut that required medical treatment. This crime is still under investigation.

Also on Durkar Lane there was a report of a burglary where entry had been gained through the rear patio doors. This crime is still under investigation.

A dangerous dog was reported on Haveroid Lane. The dog in question attacked another dog and then the hand of the victim. The owner of the dog was not able to be traced and so this crime has been filed.

There was a report of a public order incident on Daw Green Avenue that occurred between neighbours. This crime is still being investigated.

There was a report of a domestic assault at an address on St James Road. This crime is still under investigation.

#### Durkar

A domestic related assault was reported at an address on Howard Crescent. The victim declined to prosecute the suspect and the crime has been filed.

A theft of a pedal cycle occurred on Durkar Low Lane which was witness by an off duty police officer. The suspect was arrested and bailed for the victim to be spoken to.

A domestic related malicious communication was report at an address on Denby Dale Road involving a father and son. This is still under investigation. Also on Denby Dale Road there was an interference with a vehicle where the suspect has tried to gain entry by tampering with the lock. It is not believed any property was stolen and no suspect has been identified. At another address on Denby Dale Road there was a report of a domestic related harassment. The suspect was interviewed, but there was not enough evidence to charge them with the offence.

There was a crime of damage committed on a vehicle on Durkar Lane where the vehicle was scratched. No suspects have been identified and the crime has been filed.

At the Euro Garages on Peel Avenue there were two reported make-off without payments. One of these involved a vehicle on false plates that has not been traced, and the other where the suspect later returned to pay. There was a report of criminal damage to a vehicle where two customers have got into an argument. This is still being investigated. There was also a report of a burglary other at the same location were the cash machine has been attacked and money stolen. All lines of enquiry have been completed and this has been filed.

There was a similar crime committed at the Grange Service Statement, Denby Dale Road where the cash machine was attacked. Again there were no lines of enquiry and the crime has been filed.

#### Hall Green

There was a report of an assault at an address on Moorland Drive. The victim declined to prosecute the suspect so no further action was taken.

A burglary other than dwelling was reported at an address on Hollingthorpe Avenue where there garage was broken into. Meat was stolen from the freezer as well as bicycles. The investigation is complete and no suspects have been identified.

There was a report of a public order offence on Mostytn Walk. The resident was inside the address when an unknown suspect banged on the window and was verbally abusive towards them. All lines of enquiry have been completed and the crime has been filed.

A domestic related assault was reported at an address on Micklethwaite Road. The suspect was interviewed, but there was insufficient evidence to charge them with the offence.

At another address on Micklethwaite Road there was a report of a burglary other than a dwelling where a secure lock-up was broken into and fishing tackle stolen. This crime is still being investigated.

There was a report of a burglary dwelling on Hollingthorpe Court. Entry had been gained through the rear patio doors and prescription medication was stolen. All lines of enquiry have been completed and no suspects have been identified.

There was a theft from shop from the Co-op, Stoney Lane where the suspect stole meat items. This crime is still under investigation.

### Chapelthorpe

There was a report of criminal damage to fencing at an address on Hall Lane. All lines of enquiry have been completed and the crime has been filed.

#### Newmillerdam

There was a report of a burglary other than a dwelling at a commercial property on Barnsley Road where slate was stolen from the roof. No suspects have been identified and the crime has been filed.

#### **Calder Grove**

An assault was reported involving neighbours on Denby Dale Road. The victim declined to prosecute and so the crime has been filed.

There was another neighbour related crime on Hollin Lane where the suspect threatened to assault the victim. Again the victim declined to prosecute and so the crime has been filed.

A burglary occurred at Winden Close where suspects gained entry through a bathroom window and stole property. The investigation is ongoing.

Two drivers were involved in an argument on Denby Dale Road that resulted in an assault and public order crime being recorded. Neither party wanted to pursue the matter, and so the crimes were filed.

At Cedar Court there was a theft from an insecure staff locker where cash was stolen. All lines of enquiry have been completed and the crime has been filed.

A theft was reported from the garden of an address on Primrose Lane where electrical cable was stolen. The occupant chased the suspect and recovered the property, but the suspect made off and no details were obtained to allow them to be identified. The crime has been filed.

### **Anti-Social Behaviour:**

#### **Calder Grove**

There was a report of a suspicious vehicle seen entering fields off Winden Close. This was a Land Rover and may have been lamping.

There was also a call about a nuisance neighbour on Hollin Lane who was causing a disturbance when drunk. This was a repeat caller and was being called in for the purpose of logging.

The residents of an address reported a suspicious incident via a member of the Parish Council. They were approached by a male claiming to be working on the drains next door and requested that they pay for half of the cost of the work necessary. They challenged this and the male left. This has been reviewed by CID.

### Chapelthorpe

Two males seen by security near an address on Church Lane. Police attended and checked males. No offences identified.

### Crigglestone

There have been 8 reports of fly tipping on Daw Lane, Daw Green Avenue, South View, Painthorpe Lane and West View.

A male was seen acting suspiciously on Fishponds Drive. He was looking into gardens. The caller challenged him and he stated that he was looking for something that had been stolen from his brother. Police attended but were unable to locate him.

There was a report of two people hiding in the garden of an address on Durkar Lane. Police attended and could not locate anyone. They also spoke to the occupants of the address and they had not seen anyone.

There was a report of nuisance youths throwing stones on Swallow Way. No damaged caused. Police attended but could not locate youths.

#### Newmillerdam

There were three reports of fly tipping. These were on School Hill and Barnsley Road (x 2).

There was a call regarding a car parked on Barnsley Road in which the caller believed was a handgun. Police attended and this turned out to be a child's Nerf gun.

#### **Hall Green**

There were two suspicious calls on Copeworth Drive. One related to someone knocking on their door and running off. The other related to someone believing that they disturbed someone in their garden. Police attended and could not locate anyone.
