Safe Scheme Patrols:

PC342 Firth has attended to the businesses in and around High Street and Bull Lane to speak with the manager/logistic manager to try find a solution regarding the HGV's heading down Durkar Lane. This was met with positive attitude by those spoken to. They advised that they shall pass the information on to their partnership agency companies to educate them also. Security around the site will also monitor and advise any drivers seen to be driving on Durkar Lane. PC Firth also spoke with any HGV drivers who were there during this time.

PC Firth has also conducted Foot patrol in and around Crigglestone. This is in response to high calls for service as seen by the above tables. During the patrol, members of the public spoke with PC Firth and were happy to see officers out and about. During the time, there were no active calls of ASB, damage or suspicious circumstances in the area. I spoke with Christine Platten who was in Betty Eastwood Park, she informed me of criminal damage being caused by burning within the park. There was no call for service for this nor anyone seen around to approach and question. A post was sighted to have fire damage to it, however, no one was nearby nor any CCTV.

PC Firth also conducted Speed checks on both Denby Dale Road East and Denby Dale Road and issued 6 tickets for speeding. Again, the members of public were happy to see the police. There is a plan for a traffic operation to take place over the next week or so (providing operational demands allow this – it will NOT be part of the safe scheme, however, is in the Calder Park/Denby Dale Road area)
