Safe Scheme Patrols:

- On 13th November 2021 – PC342 Firth attended to Betty Eastwood Park, completed foot patrol in the area from 5pm until 5.30pm. This is regarding nuisance youths in the area, on arrival and throughout, no youths were seen or spoken to as no concerns were raised. From 5.45pm I attended to Newmillerdam via school hill for ASB purposes however no concerns or issues at the location. At 6pm attended to Calder Park services regarding recent information to youths gathering at Starbucks and causing a nuisance to customers. This appears to be a daily reoccurrence; however, no youths were located and no concerns. At 6.15pm attended to Daw Green avenue, no youths or issues raised then. At 6.30pm attended to Chapelthorpe near to the church again for ASB regarding nuisance youths near to or on the green however none were located. At 6.45pm attended to Durkar Lane to monitor vehicles, observing for no insurance, tax or MOT until 7pm however, no vehicles were highlighted as a concern.
- Sgt 6851 Rhees-Cooper completed 2 hours of patrol both on foot and in car. This included Betty Eastwood Park, Calder park Services, Stores lane, Slack lane, Newmillerdam, Denby Dale Road, Durkar Low Lane, Denby Dale road East and Cedar Court Hotel.

I would like to apologise for the lack of hours being completed during November 2021. This was partly due to PC342 Firth being admitted to hospital therefore unable to manage the scheme successfully and complete the hours he would normally complete. PCSO 913 Woods who normally completed 10 hours of overtime has since quit WYP and therefore hours not completed without a suitable replacement being found. Two traffic officers were signed up to complete 5 hours each however, hours not completed. Communication has been sent to both officers to justify and explain their absence.

December 2021 is fully booked for overtime and January 2022 is mostly booked. I am in the process of arranging more reliable officers to complete overtime on a guaranteed amount and for the quality of overtime you expect.

Can it be discussed as to anything specific that the council want officers to do/complete during December and January? ASB patrols and traffic enforcement will be the standard work expected. However, anything other than this, please let me know. If there are any events such as Christmas fairs or markets etc that you wish for police attendance, let me know the dates/times and I will try accommodating an officer for it.

Also regarding the report above (Page 1) I have added the previous LFL year for a comparison. I have also removed the 0's which in my opinion made it look messy and harder to see the actual incident numbers. Please let me know your thoughts.
