### Working in partnership to reduce crime

**September 2022 Report** – Painthorpe Travellers were the obvious issue caused within September – These were on the Hall Green Football Team field on Painthorpe Lane however, they were issued with a S.61 notice and gone within 3 days. This was prior to the event to be held on the weekend which went ahead without issue. On Daw Green there were 'gang' issues which meant a vehicle was set on fire – this is being investigated – suspects have been arrested and enquiries are on going to get a positive charge to court result. This was not a stranger/unknown person situation therefore tension in the community should be normal and no threat or fear should be felt as it was a targeted attack.

NPT Rural have completed acquisitive crime deterrent in areas which also included time in Crigglestone. This is where officers attend the area in plain civilian clothing and try to blend in and catch criminal activity ongoing and prevent it happening and making arrests. They work alongside officers in marked Police vehicles stationed nearby for assistance. This will be completed from now through to March 2023.

As shown above - No burglaries in the area for a month is great results. There were 2 vehicles stolen - however - 1 vehicle was a reported lease vehicle which was recovered by its finance company 3 months prior to the report therefore not a true crime.

There has been a large increase in ASB with people riding on motorbikes. This is being monitored and information/intelligence is coming in for those committing this ASB and will be dealt with appropriately. Due to certain health and safety risks – officers are discouraged from pursuing these due to the risk of serious injury to those riding the motorbike and the penalties imposed to WYP for this action. Therefore information from the community is greatly appreciated.

Councillor Samantha Harvey is wanting to re-start the challenged area of Durkar Low Lane/Durkar Lane/Denby Dale Road East — This is relating to the road layout, round-a-bout, crossing and parking issues in the area which has been put to Parish Council previously by WYP and residents. There was a recent single car collision into the telegraph pole which was most likely due to speed/no attention along with the wet weather. Luckily, no one was injured but strengthens the argument this needs to be looked at.

During this time, I dealt further work with the travelling community who were still present on the field. Early NPT teams had attended and Issued the S.60 warning telling the travelling community to leave by 7pm.

Around 2pm (prior to my start time) - the travelling community attended the shops and stole several items upto approx value of £300. This was from Coop and JJ off licence on Painthorpe Lane.

I attended and spoke with the painthorpe community and store staff who shared their concern with the travelling community. Coop shop manager also attended to inform me of the theft from their store. All parties at this point voiced their concern about further incidents. I obtain approval from Sgt Rhees-Cooper to allow myself and PCSO George to remain with the stores a while to ensure no further offence occured.

During this time, I arranged a large number of other officers to attend and park up to block access to the ALL BLACK RUGBY GROUND for when the travellers eventually move on. There was a charity event and football tournament due to take place on the two fields therefore community tension was high.

Once all officers were in place. PCSO George and I attended the travelling community again, reminded them to leave for 7. One group refused to leave and started to spread the word to stay. At this point, I further reached out to the WYP Supervision to get more officers in the area to assist due to the up coming engagement due to take place if they did not leave along with crowd control of the Painthorpe community as there were just the two of us. This assistance from WYP was refused.

Luckily, the travellers decided to listen to my instruction and started to pack up. All the encampment left the site at 8pm and I followed them out of Crigglestone and left them on the M1 North heading into Leeds after J42. Besides the issues caused by the travelling community and very high tension, the community was pleased with the Police intervention. In 2 days of my involvement they were gone. The tournament can go ahead as planned along with the community charity event.

#### **PC342 Firth Reports**

On Tuesday 13th September 2022 between 5pm and 7pm I attended Crigglestone for Safe Scheme Overtime. During this time, there was a travelling community present on the HALL GREEN JUNIORS FOOTBALL GROUND. They set up on 12th September and were still present. I attended the location, spoke with the travellers and they stated they were going in a day or two. I remained on site and spoke with various individuals whilst obtained information about the vehicles and their names.

Report was submitted as I believed they met the criteria for a S.61 removal notice which was authorised by Sgt Rhees-Cooper. It is left to be escalted within WYP for authorisation.

There were a number of calls for service relating to the travelling community some regarding suspicious behaviour which I checked out and turned out to be false.

I remained in the local area to reassure the community and keep control of the travellers.
