Good evening,

This month we have seen 6 Burglaries in the area and 1 theft FROM a vehicle. This is relatively the same as the year previous. NPT Rural completed Burglary and Theft of vehicle patrols during the early hours of the morning on foot in plain clothes to try capture crime in the progress. During this time, it was a negative gain but there were also NO reported burglaries or thefts during the overtime also.

On Thursday 17th November – I was completing overtime as part of the safe scheme. Whilst patrolling Hollin Drive estates, I arrested 2 individuals who were linked to a failed police pursuit causing a large crash on the M1 above the Hollin Drive estates. This was a great success, and the result wouldn't have been as such without the overtime from the safe scheme!

PC 6254 Varley (RPU) reports:

At 11:30 - 14:00hrs on Wednesday 30th November 2022 I have attended the Crigglestone arera for patrol in relation to the Safer Scheme. I had been asked to pay particular attention to Cliff Road. I have conducted static speed checks at this location and had the following results:

4 x warnings - exceeding 30mph (betwen speeds of 31-35mph)

This location at this time was extremely quiet with very few vehicles passing.

Static speed checks also coducted on Denby Dale Road:

1 x TOR - exceeding 30mph (52mph)

6 x warnings - exceeding 30mph (between speeds of 31-35mph)

Incident of note:

A confirrmed cloned vehicle was sighted heading south on the M1 J40 believed to be heading to J39. I have followed the vehicle into the Woolley Edge Services. The vehicle has then made off driving the wrong way up the motorway and exited at J39 Denby Dale Road. Area search conducted. Crime recorded for driving dangerously and enquiries are ongoing.
